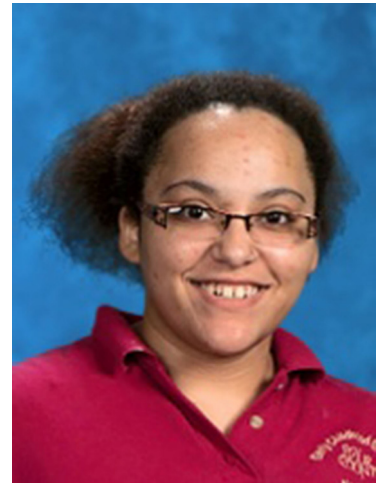


Students of the Month - October

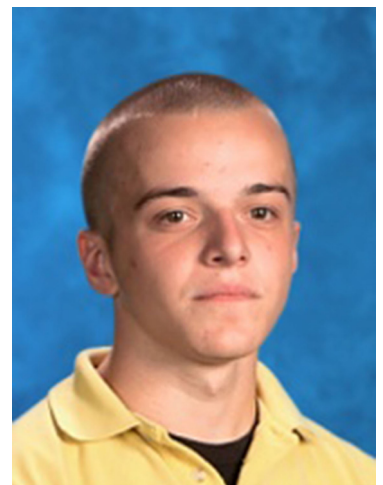

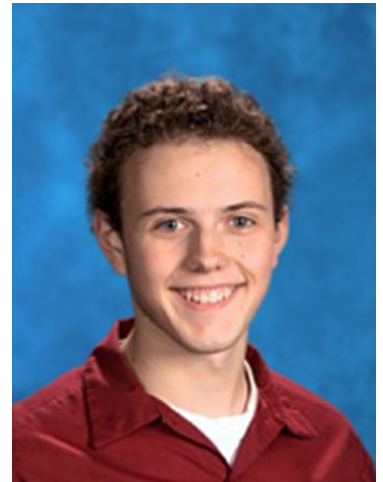
